

SUMMARY OF BOARD MEETING HELD 24TH JANUARY 2013

Children's Services Improvement: Sue Westcott reported that the number of weekly referrals are stabilising having peaked during December but the number is still high compared to neighbours and national figures and asks partners to see if a CAF could be completed before making a referral and to also look at the Multi-Agency Support Groups.

Clare Lodge Secure Unit Update: Judy Jones informed the board that Flick Schofield was concerned to know about safety at Young People Secure Units. Judy Jones commented that it would be useful to receive an annual report to the board to get a sense of what is happening even though Ofsted inspections have been rated as satisfactory. A comment raised was to target all residential units in the area and collate into a report.

YOS Safeguarding Report: Iain Easton reported that the Youth Justice Board will flag up if no assessment has been completed when a Young Person is placed. It was discussed that the child would become Looked After which means a health assessment would need to be completed within 28 days however most children who are remanded in custody are only placed for a short period and would be moved before the 28 day period.

Child Sexual Exploitation update: Judy Jones informed the board that the CSE Strategy now has a statement of intent and wanted to point out that it is multi-agency work. The CSE group has broadened to include Missing Children and workshops are being held to go through the risk assessment

Children in Need procedures: Sue Westcott informed the board that the Children in Need procedures have been revised and brought up to date. The process is similar to child protection procedures and is designed to give agencies confidence. Sue Westcott asked agencies to take back to staff and ask them to participate in meetings and ensure they comply.

Threshold Application Audit: A multi-agency audit was carried out to see how thresholds were being applied. The audit group looked at 20 and found 2 cases to be poor. SW questioned some of the information and said she would want details. RP replied saying that the 2 poor cases were picked up and revisited but will look further and liaise with JI and SW.

GP Training: Helen Herron informed members that for GPs to become accredited and to continue practicing they will need to have completed level 3 training. The PSCB has agreed to provide 4 halfday training sessions throughout the year with Cambs LSCB. GPs will be charged £25 for the training which will come back to the LSCBs.

Missing Children: Denham Hughes reported to the board that during the year there have been consistently higher rates of missing incidents reported by the police to the 0-19 Service contact. DH mentioned that other local authorities appear not to collect data on missing children in a similar way which means he is unable to provide comparable statistical neighbour information, however Cambs are considering adopting Peterborough's model.

Mark Hopkins commented that he was happy in principle to endorse the proposal and move forward with eyes open regarding the cost.
