On 17 March 2010, the Government published \*'The Government's Response to Lord Laming: One Year On'\* and \*'Building a Safe and Confident Future: Implementing the recommendations of the Social Work Task Force\*' alongside a commitment to invest more than £200m to support social work reform and improvement in 2010-11.



# Female Genital Mutilation Campaign

In order to raise awareness of FGM, the Department for Children Schools and Families has been working with the Foreign and Commonwealth Office, the Home Officer and the Department of Health to develop materials on FGM. The poster has been developed in collaboration with specialist organisations and professionals with expertise on FGM. It is aimed at professionals and also at families within communities that practice FGM. It intends to draw attention to the negative health effects of FGM, the illegality of the practice, and to signpost them to a new government FGM website: www.fco.gov.uk/fgm. The leaflet is a generic document, designed to convey key messages about FGM and challenge existing myths about the practice. The leaflet directs readers to the new website. The website is intended to act as a one stop shop for any questions about FGM, in addition to providing information and resources for professionals. victims and survivors.





#### Child Accident Prevention Trust

Staying Safe survey reveals that parental concern does not reflect the real risks to children

Key findings from the *Staying Safe survey*, published in February by the Department for Children, Schools and Families, confirm a large disparity between parents' perceptions of the risks to young children and what the actual risks are.

When asked about their main safety concerns, only 19% of parents of under fives mentioned safety in the home. When prompted, this rose to 31%, compared with 73% who cited concerns about strangers and paedophiles, 56% about bullying and 51% about online safety. Yet accidents in the home are the leading cause of hospital admissions for children under five.

Almost half (46%) of the parents with children under five agreed that people worry too much about accidents in the home, and the same percentage agreed that accidents are part of growing up, so they don't worry about them. These statistics, say the report, suggest that some parents 'have an underestimation of the risks in relation to accidents in the home.'

Two thirds of parents with children under five agreed that accidents are a learning experience and that children will be more careful next time. In its guidance to practitioners, *Accidents and Child Development*, CAPT advises:

'n be difficult for parents to remember that just because their child is now walking, talking and generally acting much more like a child than a toddler or baby, they are not necessarily ready for more responsibility. A four year old is still an impulsive, forgetful and physically and emotionally immature little person. While undoubtedly they will be learning more and more each day, they are still in need of an adult's guidance and supervision.'

"Please help us spread the message – the findings from this survey provide a good starting point for breaking down parental misconceptions about child safety in the home."

The survey was carried out last year and consisted of face-to-face interviews with over 400 parents or carers of children under five.

### **Children's Legal Centre**

The Children's Legal Centre has launched an exciting and innovative new website: <a href="https://www.lawstuff.org.uk">www.lawstuff.org.uk</a>



The website provides a wide range of information to young people about their legal rights and the laws affecting them.

The website contains information on the rights of young people and the laws that affect all aspects of their lives – education, healthcare, discrimination, policing, age-based laws, leaving home and more. It also contains information for young people who are in care or leaving care and for migrant children.

The information on the website is presented in an accessible, interactive way, through questions and answers, a 'mythbusters' tool and case studies. The content, functionality and features of the website will be added to throughout the year, including through the addition of vodcasts.

Lawstuff was developed in recognition of the lack of legal information available that is specifically aimed at young people. The content and design of the website was informed by the views of a diverse group of young people, which the Centre gathered through a series of youth forums that were held across the country last year. Young people taking part in these forums gave us a lot of information about what they would want from a legal website and the legal issues that are relevant to their day to day lives.

# **Education Safeguarding Update**

Following the increased Ofsted priority being given to safeguarding I have updated a number of our templates to incorporate the latest developments. These will be circulated to schools for their use or adaption as they wish. The new documents are

- Revised Model CP policy to include contact numbers
- Updated Annual Report to Governors this now includes a request for some more statistical information and training details which will be useful for schools to have to hand to demonstrate to Ofsted your inter agency/partnership working and responsiveness to local issues. Please remember to copy this annual report to me as this rarely happens and we have a responsibility to monitor the level of education safeguarding activity. For this reason we also ask to be copied in to referrals to Children's Social Care but this does not always happen
- Revised concern form with a reminder about passing concerns to designated persons for collation and a suggestion to consider the need for a pre-CAF assessment

Can I also take this opportunity to remind you of the importance of passing on child protection records to new schools when children leave your setting? There have been a couple of incidents recently when the receiving school has not had a complete picture of past concerns which would have provided a useful context to later issues

I am in the process of delivering honour based violence training to school staff. Please contact me if you have a staff meeting when this could be included – the presentation is about half an hour and includes information about forced marriage and female genital mutilation. The Attendance Team are distributing FGM awareness posters and we have leaflets also available

The Department for Children, Schools and Families is currently carrying out a number of important consultations including:

- Revised Guidance on Safeguarding Children and Safer Recruitment in Education;
- Controlled Activity Category in the Vetting and Barring Scheme;
- CRB Disclosures for Safeguarding Purposes on Workers already registered with the Independent Safeguarding Authority.

Please have a look at the proposed changes which mostly centre around safe recruitment and implementation of the VBS and respond on an individual basis or forward to me any comments you wish to be included in a LA or safeguarding board response

Finally you will be aware of that the Attendance Service is to be incorporated into the Children in Need team and I will not be moving with them but am to take up an Education Officer Safeguarding role. The details of this are not as yet finalised but I will advise you when further information is available and look forward to continue to work with you on safeguarding related matters in the future
