



A new protocol to safeguard children and young people who go missing from home and care has been endorsed by Peterborough Safeguarding Children Board and the Children's Trust Partnership Board.

In Peterborough last year, over 140 children and young people were reported missing to the police, with a number going missing more than once. Some of these young people are already well known to services and are getting appropriate support. For others, going missing can be the first sign that something might be wrong. Fortunately most return home without incident, but some young people find themselves in very risky situations and being away from home can make an already vulnerable young person even more vulnerable.

The protocol is a joint agreement between Cambridgeshire Police and the Council's Children's Services. It updates guidance for practitioners and managers across all services that work with, or come across children and young people who are missing from home and care. It includes a summary of legal responsibilities and what the law says regarding those under 18 who run away or go missing.

It also marks the launch of a new single point of contact within the Council's 8 to 19 Service to enable earlier intervention and preventative work with young people who go missing.

This new service went live on 1 June, and is informed by the police when a young person is reported missing. Once the young person is located and returns home, a Connexions Personal Adviser contacts them and their family to offer an independent visit and a listening ear. They will then establish if any further support is needed and either provide this or refer on for more specialist help where appropriate.

Since its launch in June, the single point of contact has been notified of 47 missing young people, Connexions personal advisors have undertaken 27 visits and 8 young people are now accessing additional support as a result.

#### **Ofsted Inspection Update**

In August 2011, Ofsted undertook a follow up inspection of safeguarding arrangements to evaluate the progress made since previous inspections to ensure that children and young people are properly safeguarded. The inspection process was a thorough one and involved the review of case files as well as discussions with children and young people, officers and elected members. Their judgement was that safeguarding arrangements were inadequate and did not meet minimum requirements. Capacity for improvement was also assessed as inadequate as were five of the seven judgement areas that contributed to the overall assessment. The inspectors found that insufficient improvement progress had been made since previous inspection visits and that the quality of assessment, management oversight and the response to risk was too variable. Inspectors also found that leadership and management arrangements, performance management and quality assurance were not sufficiently focussed to sustain improvement.

The inspectors did note examples of good practice, the improvement of the Peterborough Safeguarding Children Board and "the consistent and sustained commitment of elected members to strengthening safeguarding arrangements"

Improvement support is being provided to the Council through the sector led improvement model. This involves support being provided by practitioners from other local authorities or with considerable local authority experience. The sector led model has the support of the Department for Education as the primary means through which local authorities secure improvement and improvement capacity.

The Ofsted inspection focused on the Council's arrangements for contact, referral and assessment within Children's Social Care. The improvement activity has been planned to cover this area and the wider safeguarding arrangements within Children's Social Care, Children's Services and partner agencies.

The improvement work will involve the following activities:

- Quality assurance reviews of 180 cases subject to contact, referral and assessment arrangements over the last six months.
- An operational review of contact and referral arrangements with a view to identify and implement immediate improvements.
- A review of performance management arrangements, including audit and quality assurance arrangements to identify improvements.
- A review of the arrangements for notification, referral and response to Domestic Violence.
- The appointment of an Associate for Safeguarding to add overall capacity for delivery of the Improvement Plan, to review the capacity of the social care workforce and develop a programme of support for practice improvement.
- A review of early intervention and prevention activity to support the development of a new long term prevention.
- Consideration of the corporate and democratic contribution to safeguarding and overall programme coordination.


The work will focus on securing immediate improvement whilst preparing a diagnostic that will form the basis for a longer term action plan. The diagnostic and action plan will be discussed with the minister, Tim Loughton at a meeting in late October.

PSCB will be kept up to date with progress and partner agencies will be involved in the improvement work. The response to the Ofsted report and securing the necessary improvement requires the involvement and engagement of all services and agencies involved in safeguarding.

#### Caring about carers: new strategy and service to help young carers access

#### Who are young carers?

Young carers are children and young people who look after a parent or relative. This care can range from cooking, housework, shopping, looking after younger siblings to personal and emotional care. They may miss school and fall behind in school work, e.g. because they are up late looking after a parent or have to get younger siblings up and out to school. They may be reluctant for others to know about what they do for a variety of reasons, perhaps not to seem different or if the parent they look after has mental health, alcohol or substance misuse difficulties.

Peterborough now has a Young Carers' Strategy which has been endorsed by the Children's Trust Partnership Board, the NHS Peterborough Board and the Carers' Partnership Board.

Key aims of the strategy are to:

- · Improve early identification of young carers across adult services, children's services and in schools
- Increase awareness of the particular needs of young carers as part of a 'whole family' approach
- Reduce inappropriate and excessive caring responsibilities for young carers to give them a better chance to succeed in education and employment.

A new Young Carers Service was commissioned for the city toward the end of last year, and KIDS now run a young carers project which is already giving support to around 50 children/young people and their families. In addition to one to one support, KIDS run a range of activities after school and during holidays to give young carers a chance to meet other each other, relax and have fun.

# Independent Reviewing Officers - Understanding children and young people's Wishes and Feelings support and fulfil their potential

Independent Reviewing Officers (IROs) now have extended responsibilities in relation to the ongoing management of cases. Under new regulations\*, IROs must speak with children and young people in private before their review and identify any matters that they want to be considered at the review.

However, many children and young people can find it difficult to communicate with adults about their experiences and concerns, particularly if there is only occasional contact. The medium of the computer can enhance this process – both from the young person's point of view but also for IROs who are required to take on additional responsibilities within limited resources.

Viewpoint has been working with Children's Services professionals across the UK, including many IROs, to develop pc-based questionnaires that are accessible, engaging and relevant that help looked after young people and those with child protection plans aged 4 to 18 yrs to communicate their wishes and feelings as part of their review process. IROs have confirmed that using Viewpoint in this way has helped them to obtain and report on young people's wishes and feelings more effectively and efficiently than using traditional methods – such as paper questionnaires.

#### LAUNCH OF NSPCC HELPLINE MOBILE PHONE TEXTING SERVICE

The NSPCC Helpline has launched a mobile phone texting service which will allow members of the public to contact the Helpline by texting 88858. For the Channel Islands the number is 07786200001 (networks standard message rate applies). Members of the public can use the text service to seek advice and assistance and also to report concerns that may need follow up action or investigation. The service will be run on a pilot basis in the first instance until the end of 2011. We launched the new service on Monday 16 May and since then we have received a steady number of texts.

The public can send a text anonymously if they wish at no cost to themselves. On receipt of the text the Helpline will send an immediate automated confirmation response and then a specific response to their enquiry from a Helpline practitioner within three hours.

We believe that the new texting service will improve accessibility to the Helpline and enable people to act immediately. We were interested to see that in its recent report, Ofsted highlighted the importance of listening to adults who try to speak on behalf of the child and who have an important information to contribute (*The voice of the child: learning lessons from serious case reviews*, Ofsted, 2011). We believe that the NSPCC Helpline is one way in which we can listen to members of the public who have concerns.

Through the texting service, we are extending the range of options that people have for contacting the Helpline. As you know, these currently include: telephone (0808 800 5000), email (<a href="help@nspcc.org.uk">help@nspcc.org.uk</a>) and reporting on line (at <a href="help@www.nspcc.org.uk/helpline">www.nspcc.org.uk/helpline</a>). All these services are available free to users and on a 24-hour basis. We recognise that "texting" will not be a medium of communication that will suit everyone but we believe that it will be appropriate for some people. We have also simplified access to the Helpline's telephone service and incorporated our specialist Asian and Welsh Helpline services into the NSPCC's main Helpline UK wide Helpline service and are now promoting our one telephone number (0808 800 5000). Those previous separate numbers provided for our Asian Helpline and Welsh Helpline are now discontinued.

#### FAMILY NURSE PARTNERSHIP IN PETERBOROUGH

CONGRATULATIONS to Kirstie Lynn who has a new role that she describes below.

"My new role is to lead and supervise the delivery of the Family Nurse Partnership in Peterborough. The Family Nurse Partnership (FNP) is an evidenced based preventative programme offered to vulnerable young mothers having their first baby and supporting them until the child's second birthday. The programme is orientated to the future health and well being of the child, it includes intensive home visiting that is enough to make a difference, reflecting well tested theories and methodologies.

The FNP is a licensed programme, developed in the US at the University of Colorado and since 2007, successfully being rolled out across England. Over 30 years of rigorous research has shown significant benefits for vulnerable young families in the short, medium and long term across a wide range of outcomes including:

- improved early language development, school readiness and academic achievement
- improvements in antenatal health
- reductions in children's injuries, neglect and abuse
- improved parenting practices and behaviour
- fewer subsequent pregnancies and greater intervals between births
- increases in fathers' involvement
- reduced arrests and criminal behaviour for both children and mothers.

In an international review by The Lancet in 2008, the FNP was named as one of only two programmes shown to prevent child maltreatment.

My new role will start in early December and recruitment for 4 family nurses will take place over the next couple of months. Throughout the entire recruitment process a panel of young people have been involved and proven to give an invaluable insight into how they feel FNP will work in practice and the candidates that they felt are best suited for the posts".

## Professional boundaries, internet use and social networking online

#### Maintaining professional boundaries

Communication between children and adults, by whatever method, should take place within clear and explicit professional boundaries. This includes the wider use of technology such as mobile phones text messaging, e-mails, digital cameras, videos, web-cams, websites and blogs.

Staff should also be circumspect in their communications with children so as to avoid any possible misinterpretation of their motives or any behaviour which could be construed as grooming.

Staff should not give their personal contact details to children and young people including email, home or mobile telephone numbers, unless the need to do so is agreed with senior management and parents/carers.

#### How to protect your reputation and stay safe online

Act in accordance with your organisational policy.

E-mail or text communications between an adult and a child or young person outside agreed protocols may lead to disciplinary and/or criminal investigations. This also includes communications through internet based web sites.

#### Manage your personal information.

Staff are strongly advised, in their own interests, to take steps to ensure their personal data is not accessible to anybody who does not have permission to access it. This includes your date of birth and address. Identity theft is a growing crime and this information could be used to access you bank account or apply for a credit card in your name.

#### Understand privacy.

How you behave online is not the same as doing what you like in the privacy of your living room. As an employee you should be careful that whatever you get up to on the internet doesn't compromise your professional role. Privacy on the internet seldom means communications are entirely private, even messaging.

## Respect dignity.

Whether it is about a colleague, a parent or a child, never post a comment that could cause serious offence to that individual or anyone else. Respect people's right to confidentiality. It is not advisable to post pictures of children or young people you are working with. If you post pictures taken in a hospital environment and patients can be identified in the background, for example, – that would be breaching their privacy.

## **Uphold your reputation**

Remember that anything posted online could end up in the public domain to be read by parents, children, young people or your employer. Some organisations may even access social networking sites before considering you for a job interview.

#### The guiding rule is if in doubt, don't post it.

Remember humour is relative. For example, posting images and/or text about a recent stag or hen night may be deemed inappropriate. Likewise, a few 'light-hearted' comments and/or images about colleagues, children or young people may not be perceived as such by either the subject(s) of the humour or your employer.

#### Further tips for Facebook and other social network sites

- Treat your online conversations as if you were talking with people in a public space where you can be seen and overheard
- Don't post or tweet when under the strong influence of alcohol
- Learn how to adjust your security or privacy settings in Facebook. Most social networking sites allow you to control
  who can see your information. For example, at the bottom of every page on Facebook, there is a link that reads
  'Privacy'. The linked page is 'a guide to privacy on Facebook', containing the latest privacy functions and policies.
- Set your privacy settings to "only friends". Settings such as "friends of friends" and "networks and friends" open your content to a wider audience. Your privacy and that of your family, friends, colleagues and students could be compromised
- Remove inappropriate photos. Somebody else could post a photo on their profile in which you are named, so think
  about any photos you appear in. On Facebook, you can 'untag' yourself from a photo. If you do find inappropriate
  references to you and/or images of you posted by a 'friend' online you should contact them and the site to have the
  material removed.
- Make sure you regularly check and refresh your site page to ensure it is free of any inappropriate comments and/or images

Stop the network provider from passing on your details to other companies for research and advertising purposes.

For example, to stop Facebook from forwarding your details, click 'Account', then 'Privacy Settings', then 'Apps and Websites ...edit your settings'. This allows you to choose how your personal information is shared with other websites, apps, games and search engines.

#### Research statistics on the prevalence of child sexual abuse

In 2009, the NSPCC carried out a second major piece of research to give us a more up-to-date picture of child maltreatment. This time we interviewed young adults aged 18-24 years and children aged 11-17 years.

The full research findings have been published as Child abuse and neglect in the UK today (Radford et al, 2011).

Below are the key findings on child sexual abuse from NSPCC research:

One in nine young adults (11.3%) had experienced contact sexual abuse during childhood.

(Based on survey of 1,761 young adults aged 18-24 years).

One in 20 children (4.8%) have experienced contact sexual abuse. (Based on survey of 2,275 children aged 11-17 years).

Three-quarters (72%) of sexually abused children did not tell anyone about the abuse at the time. 27% told someone later. Around a third (31%) still had not told anyone about their experience(s) by early adulthood.

Crime statistics on sex offences

17,727 sexual crimes against children under 16 were recorded in England and Wales in 2010/11.

32% of all sexual crimes (54,982 sexual crimes in total) recorded in England and Wales in 2010/11 were sexual crimes against children under 16.

In 2010/11 the police in England and Wales also recorded 146 offences of abuse of a position of trust involving a child under 18.

More than one third (38%) of all rapes recorded by the police in England and Wales in 2010/11 were committed against children under 16 years of age.

#### Introduction

KIDS, the national charity supporting disabled children and young people and their families are now in Peterborough. A new Young Carers Project has been established in the City and we have the capacity to offer a short term project to Siblings of disabled children.

KIDS have a long history of supporting children with disabilities and their families, and already operate successful Sibling Support Projects in Camden and Southwark in London. KIDS also run 2 highly regarded Young Carer Projects in Hampshire and Ealing, West London.

#### The service

The Sibling Support Project will offer support to siblings of disabled brothers and sisters. The support will take the form of a series of groups where the siblings will meet other children who have a disabled sibling. The groups will work within the national charity 'Sibs' FRAME model of support:

- Fun
- Reduce isolation
- Acknowledge feelings
- Model coping strategies
- Enhance knowledge

Groups will be 6 sessions after school, split over 12 weeks. This means that each session will be once a fortnight. The first group will start when there are enough attendees. There will be 12 places in each group. There will be no cost to the family for this service. Transport can be provided on request.

Groups will accommodate siblings within a 2 year age gap of each other and the first group will be for 8-11 year olds. At this stage, groups will not be suitable for children under 8 years.

Groups will be well-planned with a mixture of fun, interactive activities during which the sibling may express feelings and thoughts in a safe way. The project will adhere to a strict confidentiality policy, copies of which will be made available for those families who take up this support.

Group work will be supported by an outing on the 6<sup>th</sup> session and 2 or 3 outings during school holidays in order for the siblings to spend some time with new friends and celebrate achievements.

A Parent Workshop facilitated by 'Sibs' took place in June 2011 and was well-received. Following the workshop, there will be regular parent support sessions, initially facilitated by the project but with a view to them carrying on after the project has finished by the parents themselves.

#### **CEOPS Strategic Overview Report 2010-11**

The Child Exploitation Online Protection Service have published their annual report containing the following key points

CEOPS received 6,291 reports in year up to March 2010 (5,411 in previous year), more than 1000 children were rescued and 132 networks have been dismantled in last 5 years (414 children in the last year)

There have been 1,644 arrests (513 in last year) and another important achievement has been the introduction of ClickCEOP button on social networking sites.

Clicking the CEOP button provides access to a range of support services and makes a report to CEOP if someone has acted inappropriately towards a child or young person on line. This may be sexual chat, being asked to do something that makes them feel uncomfortable or someone being insistent on meeting up

The report also identifies a significant increase in

- self taken images
- women abusers use sadistic behaviour
- online risk taking

#### Risk taking by children

CEOPS calls this the most worrying and significant trend in the last year.

11-16 year olds spend an average of 2.5 hours online a day and 75% use instant messaging. Another concern is the early sexualisation of girls, who are encouraged to look older and appear to be sexually available. These girls can engage in risk taking behaviour at first contact and are uncooperative with investigators due to their perception that they are in a meaningful relationship. Other issues are sexting, sexual screen names in chatrooms and shagbands

#### Online grooming

Out of an adult population of 37.4million, 26million use Facebook and online grooming has been the single largest issue for reporting to CEOP and the most prevalent kind of offending behaviour. CEOPS assert that

- internet has changed the pace of grooming
- · it provides an illusion of anonymity and facilitates escalation of further activity

The offender can

- take on a number of different personas adapting behaviour to victim
- create vast contact lists of potential victims
- network to share images and contacts
- · use webcam streaming

#### Victims are

- · encouraged or blackmailed into bringing friends or younger family members to get involved
- exploited without ever meeting their abuser still experience high levels of trauma and distress

Many online abusers subsequently found to be contact abusers

Those barred from working in schools exploit the inability of foreign schools to carry out background checks

#### **Trafficking**

CEOPS found that there is a significant threat from trafficking networks using more sophisticated methods. There were

- 287 potential victims in year up to Feb 2010 from 47 countries known to be an underestimate
- 72% trafficking victims aged 14-17 years old and in all regions of the UK
- 35% children were trafficked for sexual exploitation
- 18% were Vietnamese children trafficked for cannabis cultivation two thirds of these were children missing from care

#### The Knowledge

- A handy guide for maintaining professional boundaries with respect to the use of internet and social networking.

Both will be placed on the web site at the next update and included in our procedures

Support from Children's Workforce Development Council

Following on from the Munro report the CWDC is providing funding for all Safeguarding Boards to strengthen their role in terms of coordinating and ensuring the effectiveness of the changes to the way child and family social work is delivered and includes the role we play in learning and training.

#### Good Practice by LSCB's

In addition to the above, Ofsted have circulated a report highlighting elements of good practice in the operation of safeguarding boards. It aims to support the development of "learning systems" by encouraging all boards to reflect on their practice and plan for improvement.

There are a series of reflective questions for us to consider as part of this process which include: governance; partnership working; engagement with young people; quality assurance; learning from serious case reviews; measuring impact; multiagency training and learning; business planning and relationship between safeguarding boards and children's trusts.

#### Referrers Workshop

PSCB is holding another workshop on 2<sup>nd</sup> November 2-4 to review how services are experiencing the new "Integrated Front Office for Children's Social Care" as it will have been operational for 6 months

#### E Safety

The group is working to provide some guidance on developing Acceptable Use Policies for agencies and groups. Once it is prepared it will be placed on the web site.

#### Serious Case Review

We are finalising the current SCR however as the trial has been postponed until next April we will not be able to publish the summary. We will however ensure there are briefings.

#### **Publications**

The communication and information group will at its next meeting review all the leaflets and other information we produce to look at either streamlining what we produce or redesigning the information. We are aware that some leaflets were out of date as telephone numbers have changed. #### Cafcass release care statistics for August

#### Record numbers of children subject to care applications

The number of children subject to an application to be taken into care have reached record levels every month in 2011 bar one.

Releasing its care application figures for August, the Children and Family Court Advisory Support Service (Cafcass), who receives these applications form the courts, has received the highest number of new care applications for this individual month since it began collecting this data in April 2001, with 885 applications. The figures for August were also the second highest ever record for a single month in Cafcass' 10 year history.

March this year saw the highest ever number of applications received 894. The monthly average to date this year is 814 applications, compared to 754 in 2010, 710 in 2009 and 460 in 2008.

#### **Training Update**

#### **Training Impact Tool**

As part of the monitoring and evaluation role required by PSCB a Training Impact Tool has been developed to help us assess the impact that training has on practice. The short questionnaire will be available on the PSCB website from December. Three months after attending training delegates from will be sent an email with a link to the website and asked to complete the form. This will apply to anyone attending training from September 2011. Your cooperation in this process will be greatly appreciated and will enable us evaluate the effectiveness of training and to plan future training.

#### Standard Training Pack for Group A training

The Strategic Learning and development group is currently developing a standard training pack for Group 1 training. The benefit will be that this will enable us to ensure that the training provided is of a consistently high standard across Peterborough and will remove the need to have a validation panel for Group 1 training.

#### **Training Pool**

We would like to establish a training pool to provide the Group 1 training. We are looking for experienced practitioners to deliver this extremely important training to a multi-agency audience. Training and ongoing support will be provided. ## **New Allegations Management Guidance for Education**

There is new guidance which changes the definition of an allegation

from "behaves towards a child or children in a way that indicates he/she is unsuitable to work with children" to "behaved towards a child or children in a way that indicates that he or she would pose a risk of harm if they work regularly or closely with children"

The guidance also does not permit information about malicious, unfounded or unsubstantiated allegations even when repeated to be included in references

It has prompted a great deal of discussion not least because there are practical considerations in having two different sets of guidance for education and non education staff

Abuse is never OK – blaming abuse on anger, jealousy, alcohol or the other person's behaviour is not acceptable.
