### Message from the Editor


Welcome to this our first electronic newsletter, which aims to keep you up to date with all Safeguarding Board changes and developments and will be more frequent.

### New Guidance

We will also be launching '*Guidance for Working with Sexually Active Under 18*'s' at the Procedures Launch at the John Clare Theatre on 25<sup>th</sup> and 26<sup>th</sup> January 2007. This has been developed locally by a multi-agency group of professionals and contains essential guidance and a very good risk assessment tool.

# New Child Protection Conference Arrangements

In response to concerns raised regarding Child Protection Conferences being too long, a multi agency working group was set up which made recommendations to make conferences more effective. These recommendations were approved by Peterborough Local Safeguarding Children Board and which we are aiming to implement by Thursday 1<sup>st</sup> February 2007. The details of those recommendations should have been circulated within your agency.

# SAFER PARENTING HANDBOOK

Of particular importance to the success of these changes is that you fulfil your responsibility to share your report with parents and the Chair, in advance of the conference. This gives parents the opportunity to prepare their response for the conference. You should take an interpreter with you when you share your report, if a parent or carer has need for the report to be translated.

Agency members will no longer be expected to summarize their report, as everyone who is involved in the conference will have had the chance to read the reports. Instead you will be invited to comment, question or challenge what has been reported. This will leave more time and thought to the Analysis, Assessment of Risk discussion and Planning part of the conference.

# This new process will apply to both initial and review Child Protection Conferences and will be under continuous review.

### **Important Information:**

You will wish to be aware that plans have been made to implement sections 1 and 12 of the Domestic Violence, Crime and Victims Act 2004 on 1st July 2007. this confirms the commitment made by the Prime Minister on 6th December 2006.

Section 1 will make a breach of a civil order made under the Family Law Act 1996 a criminal offence and punishable by up to five years imprisonment. The Family Law Act 1996 provides victims with the non-molestation order and the occupation order. The non-molestation order forbids the use or threat of violence and/or harassment, pestering and intimidating of the victim. The occupational order enforces their entitlement to remain in occupation of the home, forces the respondent to leave the home or regulates the occupation of both parties.

Section 12 extends the powers on restraining orders under the Protection from Harassment Act 197 to cover all violent offences. It also provides the power to the courts to make an order where someone is charged, pending trial or the court considers it necessary to make an order to protect the victim. The benefit of this is that a court can make an order where a defendant has been acquitted of other charges but the court feels it is necessary to protect a person from harassment.

Both of these measures will significantly strengthen the suite of measures already available to the courts. Existing measure include:

- Amendment of the Family Law Act in order for same sex relationships to be treated in the same way and to offer the same level of protection for people in relationships but not living together.
- And making common assault an arrestable offence, so that a police Officer may arrest without a warrant under section 24 of the Police and Criminal Evidence Act 1994. this was updated by section 10 of Serious Organised Crime and Police Act 2005.
