What is Modern Slavery?

 When an individual is exploited by others, for personal or commercial gain. Whether tricked, coerced, or forced, they lose their <u>freedom</u>.

Why Slavery still exists in 2023

- Money It is the world's third most profitable crime, behind drugs and arms trafficking, causing an estimated cost to the UK in the region of 33 Billion pounds (2021).
- Unlimited access to your
 Product (Victims) Want a better life,
 Regular Income, safer and easier to transport than drugs / guns etc so less risk to the exploiter.
- Low risk / High reward MSHT hidden crime, victims often poorly educated with addiction issues or criminal past.

Labour exploitation

- Car Wash.
- Nail Bars.
- Construction.
- Care homes.
- Land / Manual workers.
- Factory workers.
- Restaurants / Takeaways.
- In reality anywhere.




Sexual exploitation

- Mostly conducted Online via adult sites offering in call and outcall services.
- Viva Street.
- Adult works.
- Street sex workers (often driven by addiction to drugs and / or alcohol.




Criminal exploitation

- Cannabis Farms (Gardener).
- Forced drug supply (Delivery and cash collection).
- County Lines (Children as young as 10).
- Benefit Fraud.



Domestic servitude

- Least visible form of exploitation.
- Victims have very little contact with the outside world.
- Only contact may be visits to health practitioners / dentists.



How Victims are Targeted

Exploiters will target their Vulnerabilities.

- Poor education / learning difficulties.
- Addiction to drugs / alcohol.
- Homelessness.
- Promises of a better life (employment / accommodation).
- Criminal offending history.
- Financial problems.
- Unable to find work via legitimate sources.

How Exploiters retain control

- Fear (of Exploiter and OCG network both here and in home country).
- Violence.
- Debt Bondage (inflated cost of travel, finding work, accommodation etc).
- Lack of understanding of rights and entitlements.
- Victims feel they have nothing to go back to.
- Lack of trust of persons in Authority (based on experience from home country or what exploiters have told them).
- Victims become dependant on Exploiters / Love.
- Unaware that they are victims (pay / conditions better than home country).

The local Picture

Labour Exploitation - County wide in many forms.

Sexual Exploitation – Mainly present in population hubs (Cambridge / Peterborough).

Criminal Exploitation – Cannabis factories (countywide).

County lines – Peterborough / Cambridge.

Domestic Servitude - ? - Likely to be in more affluent areas of county.

Identify Victims of MSHT

- Physical appearance Poor clothing, hygiene.
- Living conditions / appearance not consistent with their income.
- Poor overcrowded accommodation or high turnover of occupants.
- Access to ID and Bank cards.
- Others will often speak on their behalf or they may seek some form of reassurance from another before they speak.
- Appears subdued and uncooperative.
- Reluctant/ unable to answer questions about where they live, where they work, employers details etc.

What can I do to help?

- If you feel someone wishes to talk about their situation, give them a safe space to speak in (alone).
- DO NOT use friend or family as Interpreter.
- Allow victims to move at their pace (may require multiple interactions to build trust).
- Give them a safe point of contact.
- If a First Responder Organisation explain NRM scheme and complete as per guidelines
- If Not a First responder Organisation contact Police and / or report via the Modern Slavery Helpline.
- If something doesn't look / feel right. Trust your professional / personal instincts.

Support for victims of MSHT

- National Referral Mechanism.
- Framework for identifying and referring potential victims of MSHT and ensuring they receive the appropriate support.
- Accommodation.
- Health.
- Mental health support.
- Financial support.
- Advice and guidance.
- In a safe environment.
- Children (under 18) are supported under Local Authority.

Case Study

- Female Czech victim moved in with Aunt / cousins after the death of her Mother. Almost immediately forced into Sexual Exploitation.
- Came to the UK with Aunt. Was pregnant on arrival. Aunt forced her to give up the child for adoption. Interpreter not used during initial appointments.
- Social services attended to liaise with female re adoption. Aunt and Cousin did all the talking. No interpreter used.
- Child adopted 2014. Female sent out to work shortly after. Wages paid into Aunt's bank account.

Case Study

- Aunt claimed numerous benefits in the females name forcing her to attend medical appointments and portray someone with serious learning difficulties.
- Aunt also claimed additional carers benefits and Motability vehicle.
- In addition to this female was forced to go out to work in other family members names. Wages again paid into Aunts bank account.
- Female fled captivity in 2018 making herself homeless. Police contacted early 2019. 3 year investigation concluding in custodial sentences for Aunt and other family members involved.
